

**ORDINANCE NO. 39
BOAT LAUNCHING FEES**

The Town Board of the Town of Geneva, Walworth County, Wisconsin, does ordain that the Town of Geneva Ordinance No. 39 is hereby repealed and recreated as set out below:

Section 1

The following fees for boat launching from Town boat launches located on Lake Como in the Town of Geneva are hereby established as follows:

a. Daily Launch Fee:

Resident of the Town of Geneva	\$ 5.00
Non-Resident of the Town of Geneva	\$ 7.00
Commercial	\$ 7.00

b. Season Launch Fee:

Resident of the Town of Geneva	\$50.00
Non-Resident of the Town of Geneva	\$70.00
Commercial	\$70.00






Section 2

Anyone violating the terms of this Ordinance shall forfeit not less than Fifty (\$50.00) Dollars nor more than Two Hundred (\$200.00) Dollars together with the costs of prosecution thereof, and in default of payment of such forfeiture and costs of prosecution, shall be imprisoned in the County Jail until such forfeiture and costs are paid, but not to exceed thirty (30) days.

Section 3 Effective Date.

The repeal of the existing Ordinance and the passage of this Ordinance shall take effect from and after its adoption by the Town Board and its posting or publication thereof as required, pursuant to s. 60.80, Wis. Stat.
