

**ORDINANCE NO. 22
TRUCK PARKING ORDINANCE**

**An Ordinance revising existing
Ordinance No. 22
Regulating Truck Parking in the Town of Geneva**

Section 1.

No large truck, semi-trailer, or tractor shall be parked in any area zoned residential in the Town of Geneva or adjacent to the Town Hall or Town Shop except by permit of the Town Board.

In considering granting permission for truck parking in any area zoned residential, the Town Board shall consider the following: (i) topography of area; (ii) proximity of proposed parking area to neighboring properties; (iii) type and size of vehicle; (iv) number of vehicles to be parked; (v) frequency of times to be parked; (vi) length of times to be parked; (vii) comments of owners or tenants of properties within three hundred feet of proposed parking location; (viii) private covenants and restrictions, if any, restricting the property's use and (ix) any other matter(s) the Board may deem relevant.

Section 2.






Anyone violating the terms of this Ordinance shall forfeit not more than Two Hundred (\$200.00) Dollars, together with the costs of prosecution thereof, and in default of payment of such forfeiture and costs of prosecution shall be imprisoned in the County Jail until such forfeiture and costs are paid, but not exceeding thirty (30) days.

Section 3.

This amended and restated Ordinance shall take effect upon its passage and publication, as provided by law.
